#### 4. First Aid Measures

First aid procedures

Inhalation

Immediately flush eyes with plenty of water for at least 15 minutes. Remove contact Eye contact

lenses, if present and easy to do. Continue rinsing. Get medical attention immediately.

Skin contact Remove and isolate contaminated clothing and shoes. Wash off immediately with plenty of water for at least 15 minutes. Get medical attention if irritation develops and persists.

Move to fresh air. Oxygen or artificial respiration if needed. Do not use mouth-to-mouth

method if victim inhaled the substance. Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device.

# 5. Fire Fighting Measures

Flammable properties

Heat may cause the containers to explode. Runoff to sewer may cause fire or explosion hazard.

Extinguishing media

Protection of firefighters

Protective equipment and precautions for firefighters Water, Water fog. Foam, Dry chemical powder, Carbon dioxide (CO2).

In case of fire and/or explosion do not breathe fumes. Containers should be cooled with water to prevent vapor pressure build up. Cool containers with flooding quantities of water until well after fire is out. Move containers from fire area if you can do so without risk. For massive fire in cargo area, use unmanned hose holder or monitor nozzles, if possible. If not, withdraw and let fire burn out.

#### 6. Accidental Release Measures

Methods for containment

Stop leak if you can do so without risk. ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Move the cylinder to a safe and open area if the leak is irreparable. Stop the flow of material, if this is without risk.

Methods for cleaning up

Should not be released into the environment. Use a non-combustible material like vermiculite, sand or earth to soak up the product and place into a container for later disposal.

Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination. After removal flush contaminated area thoroughly with water.

# 7. Handling and Storage

Handling

Pressurized container: Do not pierce or burn, even after use. DO NOT handle, store or open near an open flame, sources of heat or sources of ignition. Protect material from direct sunlight. Do not smoke while using or until sprayed surface is thoroughly dry. Use only in area provided with appropriate exhaust ventilation. Do not use if spray button is missing or defective. Do not re-use empty containers. Avoid contact with skin. Avoid prolonged exposure.

Storage

Contents under pressure. Do not puncture, incinerate or crush. The pressure in sealed containers can increase under the influence of heat. Keep away from heat and sources of ignition. Avoid exposure to long periods of sunlight. Store in cool place. Keep in an area equipped with sprinklers. Keep out of the reach of children. Keep away from food, drink and animal feedingstuffs.
